ATISN 15400 – COVID Evidence

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 7 August. You requested information related to Covid 19 evidence used by Welsh Government specifically:

1. A copy of the scientific evidence available to Welsh Government that "coronavirus case numbers in Wales" represents "actual Covid 19 infections in Wales".
2. Information on the "booster vaccine" that is to be offered to the most vulnerable in Wales during the Autumn of 2021.
3. A copy of the advice to Welsh Government from the Joint Committee on Vaccination and Immunisation confirming it is safe for the public to have a different vaccine for the second dose.
4. A copy of the scientific evidence available to Welsh Government that prolonged wearing of face coverings is safe and does not lead to, or result in, hypoxia, hypercapnia or bacterial pneumonia.

Our response

1. A copy of the scientific evidence available to Welsh Government that "coronavirus case numbers in Wales" represents "actual Covid 19 infections in Wales".

Welsh Government does not hold this information.

There will always be more infected people than reported cases, as asymptomatic infected people will not have a test or seek treatment. The case numbers will always be an underestimate of actual COVID-19 infections.

2. Information on the "booster vaccine" that is to be offered to the most vulnerable in Wales during the Autumn of 2021.

The JCVI interim advice of 30 June recommends an autumn booster campaign begins in September 2021, its purpose being to reduce any further incidence of Covid-19 and

maximise protection in those who are most vulnerable to serious infection, ahead of the winter months. This was interim advice and the JCVI is currently developing their final advice, with an expected announcement in September. A link to this interim advice can be found here:

3. A copy of the advice to Welsh Government from the Joint Committee on Vaccination and Immunisation confirming it is safe for the public to have a different vaccine for the second dose

Clinical advice on second doses of the COVID-19 vaccine, including advice on using a different vaccine to the first, can be found in chapter 14a of the Greenbook. The Greenbook provides the latest information on vaccines and vaccination procedures for UK health professionals, for vaccine preventable infectious diseases in the UK. 4. A copy of the scientific evidence available to Welsh Government that prolonged wearing of face coverings is safe and does not lead to, or result in, hypoxia, hypercapnia or bacterial pneumonia.

Welsh Government does not hold scientific evidence that prolonged wearing of face coverings does not lead to, or result in, hypoxia, hypercapnia or bacterial pneumonia. However, the Covid Evidence Centre published a paper in July 2021 which looks at the evidence of harm from wearing face coverings.


