Dear Mr Jones,

FREEDOM OF INFORMATION ACT (FOIA): INTERNAL REVIEW CASE REFERENCE IR 1281190

You originally wrote to the Department of Health and Social Care (DHSC) on 10 December requesting "scientific evidence" regarding Lateral Flow Tests. We responded to you on 22 February (our ref: FOI-1281190), directing you to information in the public domain under section 21 of the FOIA (information accessible to the applicant by other means). A copy of our response, including the full text of your request, is at Annex A.

You subsequently emailed DHSC on 22 February requesting an internal review into the handling of your original request. A copy of your email is at Annex B.

This is an independent review as I was not involved in the original decision. I note your request refers to different variants that were not mentioned in the original FOI. The purpose of an internal review is to assess how your FOI request was handled in the first instance and to determine whether the decision given to you was correct. It is not an avenue through which to seek further information.

I have undertaken discussions with the team that has responsibility for your request, and we have taken the opportunity to consider it again.

Conclusion

After careful consideration of the subject matter, I have concluded that the response you received was compliant with the requirements of the FOIA and I uphold DHSC's use of section 21.

As the hyper-link only directs me to summary information and not scientific evidence that the lateral flow test can detect SARS-CoV-2 virus, including the variants listed below identified in the UK, I regret I must request that you examine the matter in more detail under your internal review process.SARS-CoV-2 variant - VUI 202102/03 - Variant under investigation.SARS-CoV-2 variant - VUI 202101/01 - Brazil Variant under investigation.SARS-CoV-2 variant - VOC 202112/02 - South Africa Variant of Concern.SARS-CoV-2 variant - VOC 202101/02 - Brazil Variant of Concern.

In responding to my request for information, I would expect a copy of a scientific report to be provided setting out the evidence, presented to D H S C, confirming that the "lateral flow test" can be used as a diagnostic tool to detect SARS-CoV-2 virus and variants now found in the UK.
