Thank you for your request for information in which you asked for:

- “1. Details of the training provided to clinicians [doctors and nurses] tasked with administering the experimental gene-editing treatments [vaccines] in Wales, and*
- 2. A copy of the literature provided to the general public, prior to receiving the treatment, to inform them of the risks of adverse reaction [including serious injury and death] to enable them to take informed decisions on whether they wish to receive the experimental mRNA / DNA based treatment, pending the end of Phase-3 trials in 2023.”*

We do not hold information on training provided to clinicians administering vaccines in Wales. We also do not hold information on literature provided to the public informing them of the risks involved in receiving vaccines.
