



**Graphene Oxide** is the oxidized form of graphene. It is a single-atomic-layered material that is formed by the oxidation of graphite which is cheap and readily available. Graphene oxide is easy to process since it is dispersible in water and other solvents. Due to the oxygen in its lattice graphene oxide is not conductive, but it can be reduced to graphene by chemical methods.

In July 2021 biostatistician Ricardo Delgado Martín, Dr. José Luis Sevillano and the team of researchers and professors with whom they have been conducting their research confirmed the presence of "*graphene oxide nanoparticles*" in Covid vaccination vials. The results were obtained by optical and transmission electron microscopy observation. The interim report is entitled "*Graphene Oxide Detection in Aqueous Suspension - Observational study in Optical and Electron Microscopy*". They reserve the results of other techniques used for future publication. They also announced that the report, based on all the techniques performed, will be made official by the researchers who performed the analyses very soon.

Brief details of Ricardo Delgado Martín's academic qualifications are set out below. He graduated in Statistics from the University of Seville; Master of specialization in Biostatistics, Postgraduate in Health Biology: Clinical Microbiology, Epidemiology and Applied Clinical Immunology from the Miguel de Cervantes European University. University Expert in Clinical Genetics from the Antonio de Nebrija University. Certificate of Scientific Contribution by the University of Seville. Ricardo is responsible for co-ordinating the Spanish research team's analysis of the impacts of graphene oxide nanoparticles contained in the vial of the mRNA gene-editing therapy [incorrectly referred to as a vaccine].

Pharmaceutical companies manufacturing the contents of these injection have not released a full list of the contents. Consequently, recipients of the injections can not make informed decisions before accepting the injections, because proper information is simply not available. This puts those administering the injections in a very precarious position, under the "Nuremberg Code of 1949", which is still in force globally. Informed consent has to be obtained before injecting anyone with an unknown substance.

The original vial of injection content was transferred to the team's laboratory by certified secure transmission through law enforcing personnel (to avoid any future accusations of tampering). On arrival, the vial was witnessed independently as the original vial's seal was opened.

The results of their analysis by electron microscopy and spectroscopy are far-reaching. Graphene oxide is a toxin which triggers thrombi and blood coagulation. It also has an impact on the immune system. Graphene oxide accumulated in the lungs can have devastating impacts.

The results of the Spanish study (yet to be fully confirmed when the paper is published and peer reviewed), suggests that the recorded vaccine related deaths and "adverse events" (published in the US by the CDC and in the EU) are attributable to the presence of graphene oxide nanoparticles contained in the Covid vaccine vial.

Of significance, (acknowledged by national health authorities) graphene oxide is also contained in face masks and nasal and pharyngeal swabs used in conjunction with PCR and antigen tests.

Graphene has electromagnetic properties which have been detected in people who have been vaccinated. These effects have been amply documented and confirmed. Reference should be made to the study conducted by the European Forum for Vaccine Vigilance.

It remains unclear, at this stage, whether previous anti-influenza vaccine contained nanoparticles of graphene oxide.

Graphene oxide is a toxic that generates thrombi in the organism, and generates blood coagulation and causes alteration of the immune system by de-compensating the oxidative balance in relation to the gulation reserves. If the dose of graphene oxide is increased by any route of administration, it causes the collapse of the immune system and subsequent cytokine storm.

Graphene oxide acquires powerful magnetic properties inside the organism. This is the explanation for the magnetic phenomenon that people around the world have already experienced after various routes of administration of graphene oxide.

Graphene Oxide poisoning causes the same symptoms of Covid 19: lung damage, blood clotting, loss of taste and smell. Graphene oxide inhibits spermatogenesis

among other things. It essentially causes the cytokine storm and renders the immune system incapable of functioning. Graphene oxide accumulated in the lungs generates bilateral pneumonias by uniform dissemination in the pulmonary alveolar tract. It causes a metallic taste. Inhaled graphene oxide causes inflammation of the mucous membranes and thus loss of taste and partial or total loss of smell.

Graphene oxide can be eliminated naturally by our bodies by "*glutathione*", a powerful antioxidant which decreases as we age. The younger one is, the higher the amounts of glutathione. It is also produced in great amounts during exercise which is why athletes have generally not been affected by Covid and in most cases have had no symptoms. Lockdowns were implemented globally: this prevented many people from exercising and naturally producing glutathione.

The Spanish researchers also indicate the danger of having graphene oxide in the body when the 5G network will be activated, lending to the idea of another 'pandemic' in a few years time when the grid will be activated and established.

It should be noted that 5G was rolled out in Wuhan China at the start of the Covid 19 "pandemic".

The annual [or biannual] booster injections would guarantee a high level of graphene oxide in the body and would not allow enough time for natural excretion of the nanoparticle by the body through antioxidative pathways.

It remains a strong possibility that the global roll-out of experimental gene-editing therapies [incorrectly referred to as vaccines] amounts to a full-fledged attack of State bioterrorism, or at least with the complicity of governments, to the entire world population, now constituting crimes against humanity.

### **Update 8 August 2021**

The contents of the mRNA gene therapy injections distributed by Pfizer mostly contain graphene oxide. Researchers discovered the substance in doses of the Pfizer vaccine: they found each dose that they examined contained around 747 nanograms of graphene oxide, meaning that more than 99 percent of the Pfizer vaccine was reportedly made up entirely of the toxic substance. That in itself is very disturbing information, provided by a highly respected research team in Spain led by Dr. Pablo Campa Madrid. The same highly toxic material when found in human bodies, is about to be used in the filtering process of drinking water in the UK. "*G2O Water Technologies*", a UK technology business, has managed to get its first commercial contract approved for the enhancement of water filtration membranes with graphene oxide. Taking what we know about graphene oxide into consideration, it is

disturbing to know that UK water is set to be treated using the very same toxic substance. The long-term health effects of washing with, using, and drinking graphene-treated water is not known.

Graphene Oxide has incredible electro magnetic properties. It is one atom in thickness, can be utilised for nano robotic functions, can be excited and controlled by radio frequencies (e.g. microwave 5G transmissions) and is easily injected into the human body. It's poisoning effect (based on dosage) mimics the published symptoms of the Covid 19 disease that the 'virus' is supposed to manifest. Like any material, graphene oxide has what we call an '*electronic absorption band*'. This means a certain frequency above which the material is excited and oxidizes very rapidly, thus breaking the equilibrium with the proliferation in the organism of the toxicant against our natural antioxidant glutathione reserves. Precisely this frequency band is emitted in the new emission bandwidths of the new 5G wireless technology. The deployment of these antennas never stopped during the pandemic.

No one has given *informed* consent to be injected, as they have not been informed of what was in the injections, that they have been pressured into taking through generated fear, of a so-called 'pandemic' that had a lower mortality rate than a mild seasonal flu outbreak.

Covid mRNA injection discoveries (by genuine, principled scientists) have revealed the tips of the extra long nose swabs used to recover material from those tested with a 'not fit for purpose' RT-PCR contained graphene oxide. Additionally, certain masks have been found to contain graphene oxide. Surgical masks produced by "*Shandong Shenquan New Materials*" were taken off the market in Spain by the national health authority, Sanidad, in April 2021, due to the discovery of graphene oxide.

*The Covid vaccines in all their variants, AstraZeneca, Pfizer, Moderna, Sinovac, Janssen, Johnson & Johnson, etc., also contain a considerable dose of graphene oxide nanoparticles. This has been the result of analysis by electron microscopy and spectroscopy, among other techniques used by various public universities in Spain.*
